Course description: In this course, we will explore the changing nature of fairy tale narratives through the study of 20<sup>th</sup> and 21<sup>st</sup> century variations on well-known tales from the European tradition of literary fairy tales. We will examine how writers have reimagined fairy tales to respond to shifting cultural and ideological conditions. Students will read variants of Little Red Riding Hood, Sleeping Beauty, Cinderella, and Beauty and the Beast by Angela Carter, Margaret Atwood, Wilfred Owen, Francesca Lia Block, Gabriel Garcia Marquez, Emma Donoghue, and Marissa Meyer with attention to both form and content. Some of the tales we will study in this course are explicitly written for an adult audience. We will discuss the use of fairy tale narratives in both children's literature and adult texts while examining the roles of the teller and the audience in the context of social, historical, material, and gendered revisions of folk and fairy tales.

This course will emphasize fundamental skills: instruction on university-level essay writing; close reading of literary texts; and an introduction to key critical and technical concepts in the study of literature.

## Assignments and Evaluation:

20% In-class Written Reading Responses (6 in total and best 5 used in calculation of grade). Reading Responses will be posted on reading schedule, but dates are subject to change. Students are expected to come to each class having read all assigned material.

15% Short Writing Assignment- Review of Critical Article in Folk and Fairy Tales anthology (500-750 words)

15% Thesis Statement, Proposal, and Annotated Bibliography for Final Research Paper (250 words)

25% Final Research Paper (1500 words)

25% Registrar Scheduled Final Exam

#### **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

- 1. Plagiarism Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
