a. Course Description

This course will introduce students to the fundamentals of literary analysis by studying representations of aliens and robots in literature. We will explore ways in which fictional narratives position aliens and robots as a cipher for race, gender, sexuality, class, and language, and we will examine how such representations either challenge or reinforce how we distinguish nonhuman beings from ourselves. What informs our idea of the nonhuman? How do writers construct nonhumans as metaphors, or more interestingly, as resistances to metaphors? What can science fiction reveal about our culture? Is the truth really out there? To answer these questions, we will study novels, short fiction, film, games, and sequential art published between the late 19th Century and the present, by creators from Canada, America, and the United Kingdom.

c. Assignments and Evaluation

Participation: Each student is expected to attend lecture regularly and participate in class discussion. Attendance will count toward students' grades, as will their level of engagement. High participation grades result from asking insightful questions, engaging in group discussions, making use of the instructor's office hours, maintaining scholarly decorum, and completing in-class activities as assigned.

In-class Quizzes: Each student will complete five quizzes in class, measuring their understanding of the texts studied. They will be administered at the beginning of a unit, to ensure that students consume the required texts *before* the lectures about those texts. Each student's lowest-scoring quiz will be dropped, and the remaining four quizzes will be worth 5% each. These quizzes will be multiple choice and short answer.

Research Questions: Each student will generate a series of research questions (250–300 words) that explore possible avenues for research paper theses. Research questions, for example, can include inquiries into a text's interplay with culture, examinations of a text's language, or interpretation of a text's narrative. We will discuss research questions more indepth in class.

Annotated Bibliography: Each student will produce an annotated bibliography (500–600 words) that consists of a finalized thesis based on a proposed research question, and three annotated bibliographic citations of original research. Annotations should address the thesis of a source, and include a critical evaluation of the source. We will discuss theses, citations, and annotations more in-depth in class.

Research Paper: Each student will write a research paper (1400–1500 words) that establishes a concrete and arguable thesis based upon course readings and supplemented with original research.

Final Exam: The final examination in this course will be scheduled by the Registrar. The examination period for the Winter 2015 term is 18–29 April 2015. Students must be available for examinations up to the last day of the examination period. The final exam will be a combination of short answer and essay-style questions and will be closed-book.

There are no extra-credit assignments. *Students must complete all assignments in order to receive a passing grade in the course,* except *the quizzes—this way, students do not risk course failure due to missed classes.*

Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each business day that the assignment is overdue.

Electronic submissions will not be accepted.

Please make every effort to take assignments directly to the instructor. If it is not possible to do so, take your assignment to ss 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. *It is your responsibility to keep a copy of all assignments in case of loss by any cause.* Please note that you are responsible for ensuring that computer problems do not interfere with timely submission of work. Keep multiple backups of all your work, at different locations. (Emailing copies of your work in progress to yourself is one easy way to do this.) Computer issues will not be an acceptable reason for late submission. Assignments cannot be returned by staff in the Department office.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

- 1. Plagiarism Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
