**Course description:**

A study of selected dramatic works by William Shakespeare: *Twelfth Night*; *Measure for Measure*, *Richard II*; *Antony and Cleopatra*; *Tempest*; and *A Midsummer Night's Dream*. The plays will be situated in their social and cultural contexts. The plays are listed in order of their consideration in the course.

**Course learning outcomes:**

1. To identify generic conventions of Shakespeare's plays.
2. To recognize and describe poetic features of Shakespeare's plays.
3. To evaluate how imaginative literature both reflects and makes cultural change.

**Texts and readings:**

The six plays in Oxford World's Classics editions are bound in a bundle available at the campus book store.

**Learning technology requirements:**

The D2L site is the organization hub for this course and students are responsible for checking the site for required readings and other course materials and announcements.

**Assessments and Evaluation:**

1. In-Class Test (closed book and no aids permitted) (25%)
2. Essay (c. 1250-1500 words) (35%)
3. Registrar-Scheduled Final Examination (closed book and no aids permitted) (40%)

All written assignments must be in MLA format (most recent edition of the MLA Handbook).

- There is a registrar-scheduled exam in this course and students must be available for examinations during the entire Examination Period (10-21 December 2022).
- There are no extra credit assignments in this course
- All assignments must be uploaded to the appropriate D2L dropbox in the format specified. No email submissions will be accepted.
- Late assignments will be penalized at the rate of 5% per date of lateness including weekends. Late assignments may not be accepted after three days without previous permission of the instructor.
- The final registrar-scheduled exam must be taken in order to qualify for a passing grade in this course.
- The quality of your writing will be an important factor in the evaluation of written course assessments

### **Reaching Me:**

Academics are usually best reached by email. Students can expect to receive replies to email enquiries within 24 hours during the business week and 48 hours over the weekend. Assignments will be assessed on the following scale. Where letter grades are used, the grade will be calculated numerically at the mid-point of the corresponding percentage scale (e.g. an 'A' is calculated at 87%). Grades will not be rounded either up or down.

Although the A+ is solely an honorific that entails no additional points in the 4-point system, the course instructor will employ this mark to distinguish superlative work that exceeds expectations in every respect.
