**Course description:** This course allows students to develop the theoretical framework for an MA or PhD thesis. The class will read selected theory texts together while students will bring a (literary/cultural) text of their choice, preferably from their own area of research, to engage in literary criticism and theorizing. Students will learn the relationship between literary criticism and literary theory and be guided in applying literary criticism to theory so as to approve, modify, or challenge a theoretical stance.

Two thinkers will act as a touchstone to our scholarship. These are Mahatma Gandhi and Emmanuel Levinas. Both have variously theorized how we think of others. Gandhi's "talisman," that we think of the poorest of the poor in our choices, and Levinas' reflections on "the ethics of the face" (i.e., how we conceive of and engage with the other) are both revolutionary concepts with great potential in literary and cultural studies. Students are invited to exploit that potential by studying the selected theoretical texts and by critiquing the paradigms of both poststructuralism and postcolonialism.

What is the significance of some of the theories for your project? How might your project be shaped by certain theories? What may be the overall contribution of the theory you choose for your thesis? These are important questions guiding the course.

## Assignments and Evaluation:

- 1. Summary (Handout and Reflections) (4 pages) on The Craft of Research: 5%
- 2. Literature Review (750 words) 10%
- 3. Annotated Bibliography 10%
- 4. Short Essay (1000 words) 15%
- 5. Seminar Presentation 20%
- 6. Research Essay (4000 words) 40%

There is no final exam in this course.

Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each day [not class] that the assignment is overdue. No assignments will be accepted one week past the assignment deadline without the prior consent of the instructor.

Assignments must be emailed as a Word document to the instructor at cjoseph@ucalgary.ca before midnight of the due date. Students must always copy themselves on any assignment emailed to the instructor, and save the item until final results are received from the registrar's office. If in doubt of the procedure, it is the responsibility of the student to check with the instructor well in advance.

## PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

(a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),

(b) parts of the work are taken from another source without reference to the original author,

(c) the whole work (e.g., an essay) is copied from another source, and/or,

(d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose.
