Course description:

Variation on a theme is one of the tried and true methods of composition across the arts. In *Stories, Various* we will exercise our curiosity about the effect of variation on narrative. For example, how is the theme of identity different in the hands of different writers? Or, how does a narrative change over two hundred years of reinvention? Or, what happens when contemporary authors write new variations on traditional tales? By considering the role of variation on the form and content of fiction, *Stories, Various* will expand students' strategies for thinking and writing about literature.

Texts and readings:

 1. Madeleine Thien's "The Wedding Cake"
 2. ZZ Packer's "Drinking Coffee Elsewhere"
 3. Eliza Haywood's *Fantomina*
- Gothic variations:
 1. Horace Walpole's *Castle of Otranto* *
 2. Edgar Allan Poe's *Fall of the House of Usher*
 3. Shirley Jackson's *We Have Always lived in the Castle*. *
- Traditional variations:
 - Neil Gaiman's *Norse Mythology* *
 - Snorri Sturluson's The Prose Edda (excerpts)
 - Leanne Simpson's *The Gift is in the Making* *

* Texts marked with an asterisk are available for purchase at the campus bookstore. The instructor will make the other texts, including supporting scholarly readings, available as required.

Assignments and Evaluation:

Midterm Test (15%)

The midterm test will consist of paragraph-length short answer questions. Short answer questions will ask students to demonstrate an understanding of both course readings and writing strategies discussed in lectures. All material discussed in class to the date of the mid-term will be covered in the examination.

In-Class Exercises (15%)

Eight times over the term, during class time, the instructor will ask students to engage in a focused discussion or writing exercise (described below). On these occasions, the instructor will take attendance. Each student's participation grade will be based on the percentage of in-class exercises attended. The dates of the in-class exercises are at the instructor's discretion and will not be announced ahead of time. Students struggling with attendance issues are encouraged to contact the instructor asap. (Please note that this instructor does not assign or accept extra-credit assignments.)

Discussion Exercises: four times over the term, the instructor will divide students into small groups and provide each group with a set of discussion questions. Students will have the opportunity to discuss readings in a small group setting. The instructor will sit with each group in turn, but the quality of the discussion depends on student participants. Discussion exercise questions (or some variation) may reappear on the mid-term test and/or the final exam.

Writing Exercises: four times over the term, the instructor will provide students with a question based on that day's assigned reading. Students will have the whole class to begin a draft response. These drafts will form the basis for the Reading Response exercise described below.

Reading Responses (20%)

Using drafts completed in the writing exercise described above, students will write three (3) reading responses of 400 words each. These three reading responses (1200 words total) must be posted to D2L by the scheduled date. Each reading response will be a polished version of the draft begun in the in-class writing exercise. When grading, the instructor will consider the student's ability to respond to the question with a logically coherent and fluently expressed argument that is fully supported by evidence drawn from the appropriate course text(s). The three reading responses will receive a single grade.

Essay (25%)

Students will write an essay of 1200 words. The instructor will provide a choice of questions. Students will choose one question and respond in the form of an essay. When grading, the instructor will consider the student's ability to answer the question with a logically coherent and fluently expressed argument, fully supported by evidence drawn from the appropriate course texts.

Final Exam (25%)

This is a Registrar's Scheduled Final Exam. Short answer questions will ask students to demonstrate a mastery of both course readings and writing strategies discussed in lectures. Essay-style questions will require students to employ specific writing strategies to reflect on the course readings. ALL course material will be covered in the examination.

→ Students must be available for examinations up to the last day of the examination period (April 16-26).

Please note the following information pertaining to assignments and evaluation in this course:

- This instructor is unable to accept extra-credit assignments.
- Students must complete all assignments in order to receive a passing grade on the course.
- Unless otherwise specified, assignments are due as electronic copies to D2L. Please upload as word or pdf files. Label the file with your last name and the name of the assignment. Do not create a title page, but on the first page include the following information: your name, the instructor's name, the course number and section, the date, and a brief, descriptive title. Please include page numbers in your document.
- Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each business day [not class] that the assignment is overdue. No assignments will be accepted one week past the assignment deadline without the prior consent of the instructor.
- Please make every effort to submit assignments directly to the instructor as directed.

Grading system: In this course, all essays, exams, and presentations will be assigned a letter grade alongside an equivalent percentage grade. The exact conversion of letter to percentage grade is at the instructor's discretion but will reflect the conversion scale below.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
 - (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
 - (b) parts of the work are taken from another source without reference to the original author,
 - (c) the whole work (e.g., an essay) is copied from another source, and/or,
 - (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
