# **Course Description:**

This course investigates diverse themes in urban and rural spaces. While exploring a range of texts showcasing different geographies, students will hone their critical thinking, reading, and writing skills. Understanding of the basic components of fiction, poetry, and criticism will develop through close reading, class discussions, and essay workshops. As Salomé Voeglin writes in *Listening to Noise and Silence: Towards a Philosophy of Sound Art*, "I cannot see to make sense but hear to understand, contingently, the meaning of my place" (133), we will engage a variety of spaces through place and time to ask how space affects and constructs our present.

# **Topics / questions for discussion:**

- 1) What is contemporary space? How do we inhabit urban spaces? How do we begin to engage with othered spaces such as rural or wilderness ideas/ideologies of space? Does the past affect our definitions or embodiment of present spaces? If so, why? Why might space be one of the most important forms of capital in the present?
- 2) Comparison of urban / rural spaces in various literary genres, contexts, and methods
- 3) Cultural histories of the required texts
- 4)  $19 c 21^{st} c spaces$
- 5) We will examine a diverse number of questions and subjects in the texts pertaining to the history, culture, and theories of urban, rural, and wilderness spaces, including ecology/environment, sound and aesthetics, global citizenship or community, gender and bodies, architecture, war, identity and nation especially pertaining to wilderness spaces and rural / urban politics.

Assignment work (any written work) must adhere to university-level standards—a minimal number (3) of errors per page—with MLA format.

Evaulation: Percentage grades are provided on assignments. A rubric and/or specific requirement criteria is used by the instructor on every assignment. The grade given is the grade for the paper. Example: if an assignment is classified as 95.2, the assignment will be given a 95.2.

**Late assignment policy:** A loss of a third of a grade (e.g., A- to B+) may be assigned for each business day an assignment is late. Assignments submitted after the instructor scheduled due date are considered late.

#### **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University *Calendar* states:

- 1. **Plagiarism** Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
