Course description:

The literature in this course foregrounds the relationship between place and the individual, where boundary crossings can result in transgressions and transformations of self. Physical spaces can create psychological barriers affecting the way we see and place ourselves in the world. We will explore how marginalization and centralization agendas can be driven by anxieties about race, gender, and nationhood. The texts studied highlight people and places in constant flux and movement, be it by immigration, genocide, an apocalypse, or enforced confinement. Staking a place in this evolving environment is not just about basic survival, but about finding a place where various versions of selfhood can coexist. Students will receive instruction in close reading and critical writing as they consider how literature as a cultural practice responds to and reflects its social context.

Assignment Descriptions:

In-class critical responses (2 valued at 10% each) <ul style="list-style-type: none">• 30-minute in-class written test where students are asked to respond critically to questions related to readings and in-class discussions.	20%
Annotated Bibliography for Final Essay <ul style="list-style-type: none">• Students must submit a one-page summary of two refereed sources to be used in their final essay, justifying their relevance to their argument, and present them in MLA format.	10%
Thesis for Final Essay <ul style="list-style-type: none">• Students must submit a one-page introductory paragraph for their final essay that must contain the thesis, methodology, and introduction to their final essay.	10%
Final Essay <ul style="list-style-type: none">• Students must submit a five-page essay plus a Works Cited List in MLA format on a topic given by the instructor which incorporates the elements from the Annotated Bibliography and the Thesis Assignment. Essays shorter than four pages will not receive a passing grade.	20%
Midterm Exam <ul style="list-style-type: none">• Students will answer short and long-form answers based on the material studied in class up to the date of the exam.	15%
Final Exam <ul style="list-style-type: none">• Students will answer short and long-form answers based on the material studied in class during the whole semester.	25%

- All three assignments related to the Essay, the Midterm, the Final Exam, and at least one in-class test must be completed to pass the course.
- Assignments must be submitted in the format required by the Instructor, which may be a hard copy or an electronic submission. Students will be given instructions on submission policies in a timely manner.
- There are no extra-credit assignments.
- If a student misses an in-class test for a medical reason, a doctor's note must be submitted in the class immediately following the absence for a retake at the discretion of the Instructor.
- Students may be subject to a verbal examination before a final grade is given on written assignments at the discretion of the Instructor.
- The in-class tests, midterm and final exam are NOT open book.

Late Penalties

- Assignments submitted after the deadline will be penalized with the loss of a third of a grade (an A- to B+) for each business day [not class] that the assignment is overdue. No assignments will be accepted one week past the assignment deadline without the prior consent of the instructor.
- Students must make every effort to take assignments directly to the instructor during class times. If it is not possible to do so, take your assignment to SS 1152 during office hours and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
 - a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
 - b) parts of the work are taken from another source without reference to the original author,
 - c) the whole work (e.g., an essay) is copied from another source, and/or,
 - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
