Course description: This course will introduce students to a range of dramatic texts and develop skills in textual analysis as well as how to read for the theatrical potential of a play script. We will consider relevant theatre history and social contexts as well as study the particular conventions of literature written for performance. Through the plays selected, we will focus on two main themes: the performance of gender on the early modern stage (*Twelfth Night*, *The Roaring Girl*) and the performance of environmental concerns on the contemporary stage (*The Watershed*, *Oil*).

Required Texts:

William Shakespeare, *Twelfth Night* (Broadview Press, eds. David Carnegie and Mark Houlahan), published in 2014.

Thomas Middleton and Thomas Dekker, *The Roaring Girl* (Norton Critical Edition, ed. Jennifer Panek), published in 2011.

Annabel Soutar, *The Watershed* (Talonbooks), published in 2016.

Ella Hickson, *Oil* (Nick Hern Books), published in 2016.

Course schedule:

This will be posted on the class D2L site ahead of the first class meeting. Students must review the schedule carefully and **make sure that readings are completed ahead of the lecture or tutorial** where the material will be discussed.

Twelfth Night performance

The play will be staged at Theatre Calgary from January 30 to February 24. Details of ticket availability will be posted on D2L. **Students in ENGL 353-01 are required to attend a performance** on a date of their own selection and are responsible for their own ticket purchase. Attendance at the production is essential in order to be able to complete the performance review assignment (details below).

Use of Electronic Devices:

Students are welcome to use laptops and other electronic devices in support of learning and for specific instructor-led tasks in the classroom. Any student found to be using a device for non-academic purposes will be asked to switch off that device and stow it away from their desk (e.g. in a backpack).

Assignments and Evaluation:

In-class tests (two, each worth 20%) – the tests will ask short content questions as well as for a detailed analysis of a key scene or passage from a play.

Performance review dossier (worth 25%) – an instruction sheet describing the required components of the performance review dossier will be posted to D2L.

Final paper of around 2000 words (worth 35%) – students will choose from a selection of topics including conventional essay-style questions and creative options.

If you are absent from the in-class tests or late with assignments for medical reasons, a medical certificate will be required to confirm the absence/delay for health reasons. Please see section E.3 Attendance in the Calendar for further information.

There will be no Registrar-scheduled final exam in this course. **Students must complete all assignments in order to receive a passing grade in this class.**

Assignment Submission and Late Assignment Policy:

Pay careful attention to the instructions on each assignment sheet. Papers will be handed to the instructor at the end of class on the due date of the assignment; **electronic submissions will not be accepted.**

Late assignments will be penalized at a rate of one third of a letter grade per day of lateness (including Saturdays and Sundays). If a paper is handed a day late, for example, a B essay will have the grade reduced to B-. Late submissions may be dropped off at the Dept. of English office or to the Department's dropbox (outside the 11th floor office). They will be date-stamped and placed in the relevant mailbox.

It is the student's responsibility to keep a copy of all assignments in case of loss by any cause.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:

- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is

not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
