**COURSE TITLE: Shakespeare and his Contemporaries**

**Course description:** An examination of the drama of the seventeenth century, examining works written for both public and private theatres as well as for court performance.

Taking Shakespeare's *Othello* and *The Tempest* as starting points, this course will look at some of the rich range of seventeenth-century drama concerned with the performativity of gender and class, the beginnings of colonial expansion and the intercultural encounter. Students will examine different types of dramatic form developed for the variety of spaces of London performance, and will think through the impacts of the work of Shakespeare and his contemporaries for understanding the social, political and economic issues of the period.

Pre-requisites: 12 units of courses labeled English at 300 level or above.

**Assignments and Evaluation:**

There will be four assignments in this class: one short paper (1000 words, worth 20% of final grade), one test written in class (worth 20% of final grade), one research paper (1500 words, worth 30% of final grade) and a final critical paper (2000-2500 words, worth 30% of the final grade).

There will be no Registrar scheduled final exam in this class. Students must complete all assignments in order to receive a passing grade in this class.

**Assignment Submission and Late Assignment Policy:**

Assignments will be submitted electronically in Word format via email to sbennett@ucalgary.ca. Late

assignments will be penalized at a rate of one third of a letter grade per day of lateness (including Saturdays and Sundays). Thus, if a paper is handed in a day late, for example, a B essay will have the grade reduced to B-. It is the student's responsibility to keep a copy of all assignments in case of loss by any cause.

Please note that, according to the University Calendar (F.1), instructors may use their discretion when rounding upwards or downwards when the average of term work and exams is between two letter grades.

Although the A+ is solely an honorific that entails no additional points in the 4-point system, the course instructor will employ this mark to distinguish superlative work that exceeds expectations in style, correctness, intellectual depth and breadth, sophistication, and originality.

Likewise, writers should follow the personal pronoun choices of individuals they write about, if their preferences are known, and editors should respect those preferences. *They* may be used in a singular sense according to a person's stated preference for it."

## **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

1. Plagiarism - Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
  - a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
  - b) parts of the work are taken from another source without reference to the original author,
  - c) the whole work (e.g., an essay) is copied from another source, and/or,
  - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:

Students who are absent from class assessments (tests, participation activities, or other assignments) should inform their instructors as soon as possible. Instructors may request that evidence in the form of documentation be provided. If the reason provided for the absence is acceptable, instructors may decide that any arrangements made can take forms other than make-up tests or assignments.
