# Course description:

Pre-requisites: Admission to the Honours program in English

This course consists of two components: an independent research project conducted under the supervision of an English Department faculty member, and a year-long seminar. The seminar component is designed to support students while they work on their independent research, as well as introduce them to other elements of advanced academic work.

## English 504 Seminar

Students enrolled in English 504 will participate in a regular seminar, led by one or more faculty members. The seminar will be conducted as a workshop based on students' individual research and writing and will also emphasize specific research, writing and professional skills, such as proposal and application writing, seminar presentations of work-in-progress, library research, and conference paper planning and presentation. The goal of the seminar is to facilitate the writing of the Honours Project by providing an environment in which students can explore issues involved in the planning and completion of a long research project.

This course will take place **online** via Desire2Learn (D2L) and Zoom. To best succeed in the course, students are encouraged to participate in the asynchronous learning tasks using the D2L learning environment and synchronous Zoom sessions. When unable to participate live due to the time difference or unforeseen circumstances, inform the instructor in advance and propose and implement propose an

alternative participation activity (e.g., watch the recordings, submit a brief reflection, and actively contribute to the follow-up online discussion).

We will meet synchronously, roughly bi-weekly in the Fall semester and the beginning of Winter, less often after completion of the Honours symposium. There will also be asynchronous elements around the planning of the Honours symposium, and the sharing and discussion of documents relating to each seminar participant's projects.

#### **COURSE LEARNING OUTCOMES**

Upon completion of this course, students will have:

- 1) Designed and completed a major independent research project in consultation with a faculty member and with members of the seminar.
- 2) Organized a symposium and delivered an academic paper at the symposium.
- 3) Learned more about the professional elements of academic studies in English.
- 4) Developed an ability to explain their academic research in a concise way for the purposes of applications to conferences and to academic and other programs.
- 5) Honed their skills of providing feedback on the work and writing of others and of receiving the same from their peers.

There is a D2L site for this course which contains required readings and other relevant class resources and materials (see d2L.ucalgary.ca).

## Texts and Readings:

Texts and Readings: Complete reading lists will be dependent on a student's individual project and research needs; however, all students are required to own a copy of the latest edition of the MLA Handbook for Writers of Research Papers (8th ed.). Copies are available at the University of Calgary Bookstore. All final papers must conform to MLA (8th ed.) style. Each week of the fall semester, one student will be asked post to D2L a selection (of no more than 10 pages) from either the primary text they are writing on, a theoretical text closely related to their project, or (in the case of creative writing students), some samples of their own writing, along with some prompts for discussion. The other students in the seminar will then read these texts and respond to the prompts both in discussion board posts and part of seminar meetings.

### Assignments and Evaluation:

Sixty percent of the final grade will be assigned by the student's supervisor, and will reflect the quality of the final version of the essay. Forty percent will be assigned by the seminar leader, and will reflect not so much the final result as the process of research, writing, and seminar interaction. The seminar leader will be responsible for calculating and reporting the final, combined grade.

#### **PLAGIARISM**

Plagiarism is an extremely serious offence. Please read the following information carefully. The University Calendar states:

- 1. Plagiarism Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
  - a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
  - b) parts of the work are taken from another source without reference to the original author,
  - c) the whole work (e.g., an essay) is copied from another source, and/or,
  - d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose.
